Runner previously served as Vice President and Global Practice Leader, Embedded Software, EE & Semiconductors for Autonomous, Connected, and Electric Vehicles at Capgemini.

The appointment of Runner as US CEO marks another leap forward for CARIAD's US strategy and follows the establishment of its new US tech hub in January 2023. With its presence in two major technology ecosystems, Silicon Valley and the greater Seattle area, CARIAD is actively developing automotive technology solutions in the areas of hardware design, automotive cloud and connected infotainment.

In 2012, Runner helped found the team that delivered Qualcomm's first two generations of automotive-grade infotainment and telematics products. Subsequently, Runner joined what became Capgemini Engineering as the Global Practice Leader for embedded software, EE, and semiconductors responsible for consulting, solutioning, developing, validating, and testing of in-vehicle infotainment, ADAS/AD and telematics products and systems for OEM and tier1 clients. He has a B.S. in applied physics and did graduate work in computer science and engineering management.
